Message from the Board

Hello Supply Chain Professionals,

Your APICS Shoreline Chapter has begun another successful year!

Our CPIM Classes have begun, CPIM Examinations are being taken successfully, our membership levels have risen and our PDMs are being well attended. Our efforts last year were again recognized by APICS with the performance level of Gold. This means that we have maintained a Platinum status with APICS; which is the highest rating a chapter can receive from APICS. Take great pride in this accomplishment! We are one of the smallest APICS Chapters but our performance is the envy of many of the larger chapters.

Recently I was able to represent our chapter at the APICS Great Lakes District Meeting in Chicago, IL. Following are a few of the key discussion points from this meeting.

- APICS will be rolling out an updated website shortly.
 Watch for updates from APICS or check www.apics.org directly.
- The current CPIM program structure will be changing in 2017. The structure will change from the current five (5) modules to two (2) modules.

The BSCM module will continue but with minor changes. The exam will change from the current format to 150 questions.

The MPR, DSP, ECO and SMR modules will be consolidated into one (1) class and examination; also 150 questions.

Pricing has not been finalized or published for the new structure so we do not know the cost implications.

If you have passed the BSCM examination it is planned that this will fulfill the BSCM requirement under the new structure.

There will be a transition period to allow those who have started the current CPIM process to finish the process.

It would be my recommendation that if you have started the CPIM process to finish the process this year; especially if you have just a few to finish.

- APICS is rolling out the CLTD certification this year. This certification will be structured similarly to the CSCP certification.

The APICS Great Lakes District is doing a very nice job supporting our local chapter. They are very transparent, supportive and encouraging!

Please continue to support our local chapter (www.shorelineapics.org) and consider how you can get even more involved. We are always looking for volunteers to join our Board of Directors or provide assistance at our PDMs. Feel free to contact any Board of Director member with how you can provide assistance or to share your thoughts and/or concerns. Topic: Supply Chain Challenges

Supply chain managers have seen increasing challenges to create, and keep, efficient and effective supply chain methods. The five of the biggest supply chain challenges (*source: SupplyChain247*) are as follows:

- *Customer service* Supply chain management is all about providing the right product in the right quantity to the right place and the right time. Seems simple, but can get complicated...quickly.
- *Cost control* Operating costs are under extreme pressure by rising energy/fuel and freight costs, greater number of global customers, technology, increasing labor rates and new regulations and rising commodity prices.
- *Planning & risk management* In order to stay as efficient and effective as possible, periodic assessments and redesigns are needed. These adjustments are in response to changes in the market changes such as new product launches, global sourcing, credit availability and the need to protect intellectual property. These risks must be identified and quantified in order to control and mitigate.
- Supplier/partner relationship management It is important to create, understand and follow mutually agreed upon standards to better understand current performance and opportunities for improvement. Having two different methods for measuring and communicating performance and results wastes time and effort. Trust the system that was put in place for consistent results and better supplier/partner relationships.
- *Talent* It is becoming increasingly more difficult to find qualified and interested talent. Supply chain leaders need an extensive understanding of the key competencies and duties needed for supply chain management roles and the ability to efficiently source specific skill sets and methods for developing future leaders.

APICS unemployed membership extension program

If you are an unemployed APICS member whose membership is coming up for renewal and you are actively seeking work within the production and inventory management field, you may apply for an extension of membership benefits through the unemployed membership extension program.

This program enables members seeking employment within the production and inventory management industry to extend their membership for free for an additional six months.

Note: Members may apply for this extension up to three times for coverage over an 18-month period. Members apply for the extension through their local chapter, which must approve the request and waive chapter dues. Members approved for this waiver will receive e-membership for the duration of the waiver, which includes access to all member benefits which will be delivered electronically.
