Johnsonville has overcome, and those they are still working on. It will conclude with the end state goals.


#### **Directions for the Tour:**

<u>From Manitowoc</u> - Take I-43 South to Highway 42 exit. Go South on Highway 42 about ¼ mile until you reach County Highway J. Go West (right) on County Highway J for about 9 miles. Turn North (right) on Johnsonville Way. Turn in second drive to the right. Go West Highway 23 to Cty Trk M exit. Go North (right) on M. Stay on M until you come to County Highway J. Go West (left) on J to the Johnsonville campus. Turn North (right) on Johnsonville Way. Turn in second drive to the right.

<u>From Sheboygan</u> - Go West Highway 23 to Cty Trk M exit. Go North (right) on M. Stay on M until you come to County Highway J. Go West (left) on J to the Johnsonville campus. Turn North (right) on Johnsonville Way. Turn in second drive to the right. You can park in the parking lot in any open space.
